The Dy. Educational Officer, Narasaraopet has recommended for Grant of Extension of Temporary Recognition to Classes VI to X (E.M) from **2013-2014 to 2022-2023** vide letter 3<sup>rd</sup> read above. The District Educational Officer, Guntur District has verified the application for Grant of Extension of Temporary Recognition with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G.,O.Ms.No:1 Edn., (PS-I) Rules Department Dt:1-1-1994 and submitted a report in his letter 4<sup>th</sup> read above.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn., Dt:1-1-1994 ,G.O.Ms.No. 41 Edn. Dt: 11-05-2006 and G.O. Ms. No. 74 Education, Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10<sup>th</sup> cited, the Regional Joint Director of School Education, Guntur here by accords for **Grant of Extension of Temporary Recognition to Classes VI to X (E.M) for a period of 10 (Ten) Years ie., from 2013-2014 to 2022-2023** in respect St. Mary's English Medium High School, Ravipadu, Narasaraopet (M), Guntur District without aid now or future. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abided the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more Particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by Govt. from time to time.
5. That the qualified staff with in the age limits prescribed by Govt.. for Govt.. Employees shall be appointed as per the Staff pattern.
6. That the results of the Institutions shall be satisfactory every year.

7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this orders shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to submit No Objection Certificate from Fire and Emergency Service Department every year.
16. The Management is requested to fulfill conditions stipulated in G.O. 9<sup>th</sup> read above within 3 months and submit compliance.
17. The Management is requested to renew the District Fire Officer Fire Certificate every year time to time without fail.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year **2023-2024**.

The Secretary & Correspondent, St.Marys E.M School,Ravipadu,Narasaraopet Mandal, Guntur District under the management of St.Marys E.M School,Ravipadu,Narasaraopet has applied for according permission to Grant of Extension of Temporary Recognition and permission to open additional to classes Nursery to V (EM) for 10 years 2020-2021 to 2029-2030 without aid now or in future.

The Mandal Educational Officer, Narasaraopet has inspected and submitted his report in the reference 3<sup>rd</sup> cited.

After careful examination of the proposals from the society and also the inspection report of the inspecting officer in the reference 3<sup>rd</sup> cited permission is hereby accorded for Grant of Extension of Temporary Recognition School by name St.Marys E.M School, Ravipadu, Narasaraopet Mandal, Guntur District with classes Nursery to V (EM) during 2020-2021 (EM) without aid now or in future subject to the following conditions:

- 1) That the society shall abide by the rules and regulations made in the Government orders in 1<sup>st</sup> to 2<sup>nd</sup> cited above.
- 2) That the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, Library, Laboratory equipment , play field, required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
- 3) That the society shall apply for recognition by 31<sup>st</sup> August at the latest duly fulfilling the conditions.
- 4) That the permission accorded is restricted to this year only and it is not valid for the subsequent academic years.
- 5) That this permission does not confer any right on the society for claiming recognition.
- 6) That the permission is accorded St.Marys E.M School,Ravipadu,Narasaraopet Mandal, Guntur District and no other society or body can open a school on their behalf.
- 7) That the permission is accorded to open the school premises in the locality and they shall not be any change in the premises or locality.
- 8) That the society shall provide the necessary material even if it costs more than the deposit amount.
- 9) That the Institution shall adopt curriculum and syllabus from time to time.
- 10) That the school timings, vacations and mid-term holidays shall be prescribed by the Government from time to time.
- 11) That the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.

- 12) That the list of governing body shall be furnished to the Dist.Ednl officer, every year.
- 13) That the records/Accounts, annual administrative report along with the audited accounts should be submitted to the Dist. Ednl. Officer, every year.
- 14) That the results of the institution shall be satisfactory every year.
- 15) That the pay structure/fee structure fixed by the governing body shall be submitted to the Dist. Ednl.Officer, every year.
- 16) That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- 17) That it shall not be close without giving notice both to the parents/Dist. Ednl.Officer and the competent authority at least 6 months before.
- 18) That the school shall be closed are permitted to be closed only from the date on which summer vacation is declared.
- 19) Parent teachers association should be forward as per G.O.Ms.No.216 dt.17-10-86 every year.
- 20) The management is requested to renew the play ground period after expiry of the date.
